# Fee Schedule



## Agency fees

- \$2,000 *Paid after our free initial consult. This first installment shall be paid upon signing the agency agreement in order to be placed on our list.*
- \$20,000 *Once you and your chosen surrogate agree that you are officially matched and wish to proceed on this journey together, this fee is due within one week.*
- \$23,000 *This last installment is due once your surrogate has received medical clearance from your clinic.*

*Included with agency fees: Background checks, psychological evaluations (gestational carrier, partner, intended parent, and group), gestational carrier medical records collection, IVF nurse record review, and SeedTrust escrow fee. Also included is a virtual class with a labor and delivery nurse covering labor, delivery, and newborn care, plus optional one-on-one birth planning support with your gestational carrier.*

## Estimated third party fees

- \$6,000 *Drafting / Review of gestational carrier agreement*
- \$5,000 *Legal fees to establish parentage*
- \$600 *Insurance review*
- \$900 *Health insurance policy search / placement*
- \$500 *Maternity care plan estimate*
- \$4,000 *Life insurance coverage for 2 years. \$500,000 on the surrogate paid to her beneficiary of her choice, up to \$150,000 ascertain net loss payable to you. This coverage will also include a loss of reproductive organ rider policy as well as IVF complications coverage*

*Please note: These third party fees are estimates for your planning purposes only and will vary.*

## International coordination fee

- \$5,000 *Carrying Hope shall coordinate with a third party provider specializing in international documentation, background screening, and passport processing. Services included in this fee shall consist of international background checks for Intended Parents as required for the surrogacy process; guidance regarding required documentation for U.S. passport issuance; coordination of appointment scheduling, document submission, and communication with the third party provider; and expedited U.S. passport processing for the child, typically completed within three (3) to seven (7) business days. Total fee is \$5,000 and is to be paid as follows:*
- \$2,500 due at sign-on, paid together with the initial Agency Agreement installation; and*
  - \$2,500 due within one (1) week of being "officially matched" with a carrier.*

*All international coordination fees are non-refundable when paid. If your surrogate becomes pregnant with multiples, an additional \$2,500 will be paid at the twenty (20) week mark of pregnancy per baby.*

# Fee Schedule

## Gestational carrier fees

Base compensation fee for your chosen carrier. This fee can vary for different reasons. If the surrogate is experienced her base fee is increased an additional \$5,000 - \$10,000. \$55,000

It also increases an additional \$10,000 if the surrogate becomes pregnant with multiples.

Monthly allowance from contract signing to birth \$300

Medication start fee \$250  
(This fee is for each start of medications for a cycle to include transfer, ERA and mock cycles)

Transfer fee (for each transfer) \$750

Fee for heartbeat confirmation, per heartbeat \$500

Maternity clothing fee paid at 12 weeks gestation. \$750  
This fee increases an additional \$250 if surrogate is pregnant with multiples.

## Possible additional carrier fees

Mock cycle fee if recommended by your clinic \$250

Dropped cycle fee if the cycle is canceled due to no fault of the carrier \$500

Invasive procedure to include: D&C, ectopic pregnancy, cerclage placement, fetal reduction per fetal sac, amniocentesis (per needle), Chorionic Villous Sampling, Hysteroscopy. \$500

Abortion / Termination \$2,500

Hysterectomy \$20,000

Loss of organ \$10,000

ERA \$250

C-Section (only if medically advised) \$5,000

Doula allowance \$1,500

Bedrest - weekly (includes housekeeping & childcare but not lost wages, if any) \$500

Mileage at current federal rate starting at mile 51 for any appointments the surrogate travels to for this journey.

# Fee Schedule

## Possible additional carrier fees continued

\$200	<i>Activity restriction - weekly (includes housekeeping &amp; childcare, but not lost wages, if any)</i>
\$150	<i>Housekeeping - monthly if not on bedrest</i>
<i>Actual net</i>	<i>Lost wages for carrier and / or partner</i>
\$75	<i>Daily meal allowance for travel days over four hours, per person, each day</i>
\$300	<i>Breastmilk - weekly fee, plus shipping costs &amp; supplies</i>
\$150 / day	<i>Childcare for transfer, medical screening, and monitoring appointments. \$450 a week maximum.</i>
\$2,500	<i>If a termination of pregnancy is requested on or after eight (8) weeks post embryo transfer, a fee of \$2,500 will be paid to the gestational carrier on the day of termination.</i>
